In accordance with SEBI Listing Regulations and Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information in terms of Regulation 8 of SEBI (Prohibition of Insider Trading) Regulations, 2015, the following is our business update highlighting the continued and consistent performance of the Company for the quarter and half year ended September 30, 2024 (“Q2 & H1 FY25”):

During the quarter, the C&T operation handled a record-breaking total of ~0.49 tonnes. The combined tonnage for C&T and processing reached ~1.19 million tonnes, showing a ~4.0% year-over-year (YoY) increase. Excluding expired contracts, the organic growth in volumes handled rose by ~6.9% YoY. For the first half of FY25, the total MSW volume managed was ~2.38 million tonnes, which, after adjusting for expired and completed projects, represents a ~6.8% YoY increase.

Please note that the tonnage handled by the C&T business excludes projects billed based on fixed shifts, trips, or household counts.

Furthermore, the PCMC Waste-to-Energy (WtE) plant completed its scheduled maintenance during the quarter. The plant has achieved a Plant Load Factor (PLF) of 71% since its commissioning on October 7, 2023.

During the quarter, the Company successfully sold ~30,500 tonnes of Refuse Derived Fuel (RDF) and ~4,000 tonnes of compost. For the first half of FY25, these figures reached ~64,750 tonnes and ~10,200 tonnes, respectively, reflecting YoY growth rates of ~13.8% and over 100%.

Following the conclusion of the quarter, the Company's Wholly owned subsidiary (AG Enviro Infra Projects Private Limited) achieved a significant milestone by successfully securing ~₹ 908 Crore Collection and Transportation (C&T) contract from the Navi Mumbai Municipal Corporation for the third consecutive term.

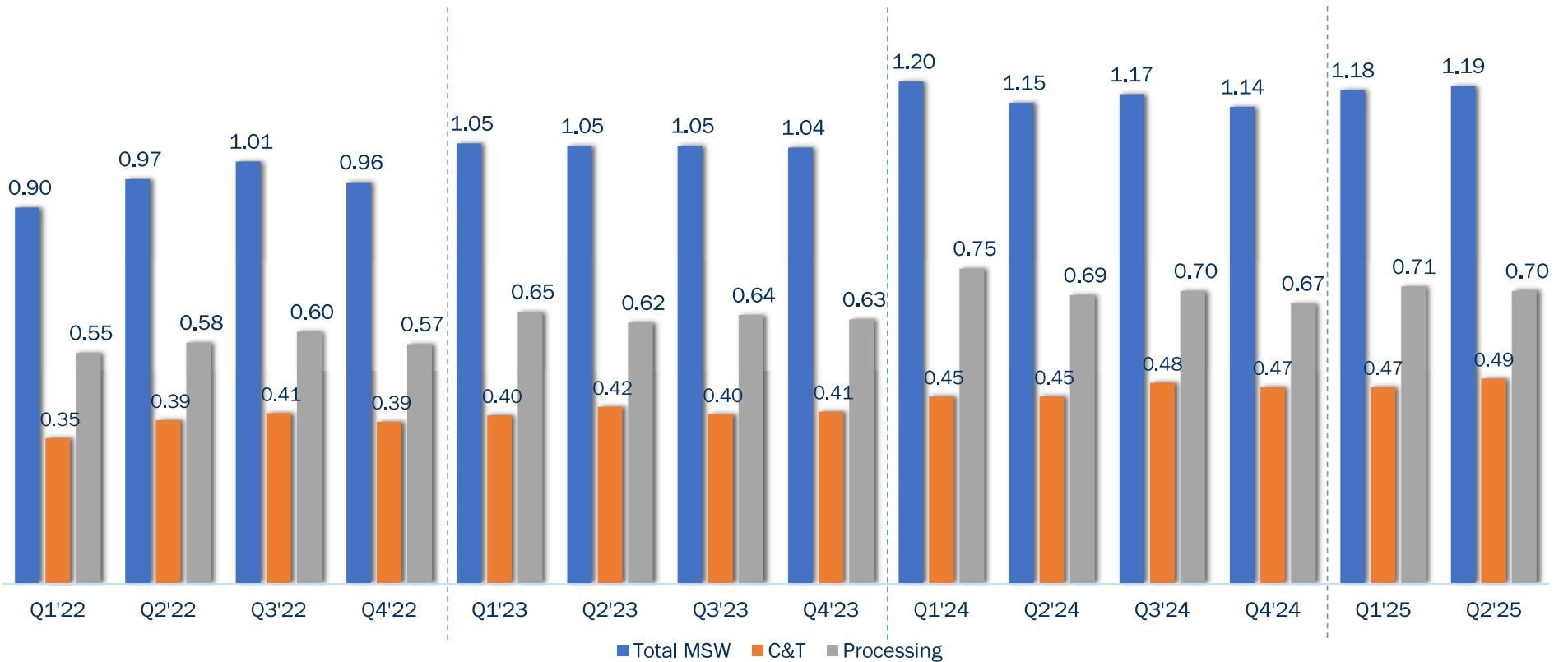
